### Experience

Valuation of a Woody Biomass Co-Generation Facility

***Seneca Sustainable Energy LLC v Department of Revenue.*** Trial before the Oregon Tax Court of the valuation of a biomass co-generation facility for two tax years. Significant factual question was the purchase price a purchaser of the property could have sold the electric output of the facility at the rates found in a power purchase contract. Court reduced the valuation of the facility for both tax years. On appeal to the Supreme Court.

Valuation of Hewlett Packard Campus in Corvallis, Oregon

***Hewlett-Packard Company v. Department of Revenue.*** Valuation trial before the Oregon Tax Court for three tax years, resulting in a judgment for Hewlett-Packard Company reducing the real market value of the Hewlett Packard Company's 178 acre manufacturing and research campus in Corvallis Campus. Affirmed by the Oregon Supreme Court 357 OR 598 (2015).

#### Easement Dispute

***Benafel v Williams Connector Gas Pipeline, LLC, 276 Or App 226 (2016).*** Court agreed that the Williams pipeline\ easement allowed it to install additional facilities above ground.

#### Oregon Department of Transportation's Failure to Comply with the Condemnation Procedures Act

***State ex rel. Dept. of Transp. v. Singh, 257 Or. App. 322, 306 P.3d 745 (June 26, 2013) Linn County Circuit Court Case No. 110469; Oregon Court of Appeals Case No. A149566.***

Successfully challenged the Oregon Department of Transportation's failure to comply with the Condemnation Procedures Act. The Oregon Court of Appeals affirmed the trial court's dismissal of the condemnation complaint.

#### Condemnation of City Well Placed on Private Property

***City of Harrisburg v. Ellen Leigh, 254 Or. App. 558, 295 P.3d 138 (January 16, 2013) Linn County Circuit Court Case No. 082737; Oregon Court of Appeals Case No. A144466.***

Represented the property owner in a condemnation case wherein the City of Harrisburg failed to compensate the property owner for a well that the City had installed on her property without her permission. The City condemned the property after the well had been installed on the property. The Oregon Court of Appeals affirmed Ms. Fraser's legal argument that on the date of the condemnation, the City had no right, title or interest in the property and Ms. Leigh should be compensated for the well improvement on the property.

#### Valuation of Xerox's Corporate Campus in Wilsonville, Oregon

***Xerox Corporation v. Clackamas County Assessor.*** Valuation trial before Magistrate Division of the Oregon Tax resulting in a reduction in the property tax assessment for Xerox Corporation's Wilsonville Campus.

#### Central Assessment of Cable Television and Internet

***Comcast Corporation v. Department of Revenue.*** Oregon Tax Court determined that the legislature did not intend to include cable television in its definition of communication services. Comcast was not subject to central assessment. Oregon Supreme Court reversed. The case is on remand in the Tax Court.

#### Food Processing Facility in Tennessee and California

***The Pictsweet Company v. Crockett County, October 2009; Chancery Court for the State of Tennessee, Twenty-Sixth Judicial District, Madison County at Jackson.*** Successful reduction of property tax for the five years under appeal.

***The Pictsweet Company v. Assessor of Santa Barbara, Application No 05.0124, June 2009.***

Representation of The Pictsweet Company in the successful appeal before the Assessment Appeal Board in the reduction of property tax.

High Tech Manufacturing Facility

***Electro Scientific Industries v. Department of Revenue and Washington County Assessor, 2006 WL 3053314 (October 27, 2006)***. Representation of ESI in the successful appeal before the Magistrate Division. Magistrate agreed with the taxpayer's valuation of the property resulting in a reduction in property tax for the high tech manufacturing facility.
