REPRESENTATIVE MATTERS

Results may vary depending on your particular facts and legal circumstances.

- Representation of a New Jersey-based client with an extensive automotive industry profile in the
 multi-million dollar purchase of two automobile franchises and related real property located in
 Georgia. The transaction involved the purchase of a Cadillac franchise, a Mazda franchise, and the real
 estate on which both dealerships are located in a complex transaction involving numerous real estate,
 environmental, factory approval, zoning and financing issues.
- Representation of an existing New Jersey automobile dealer in its multi-million dollar purchase of a Hyundai franchise and related real property in southern New Jersey. The transaction involved complex financing issues, real estate and environmental issues, and factory approval matters.
