For those who have had a prior marriage, cohabitation also raises issues regarding the suspension or termination of alimony. It is prudent for unmarried couples to sign a cohabitation agreement to protect their rights and assets, however this may not be enough. This program will address cohabitation agreements as well as other crucial consideration, including careful estate planning, beneficiary designations on retirement assets, the titling of property, and identifying who will make medical decisions on behalf of a sick partner.
