Dennis A. Estis Named Best Lawyers' 2010 "Construction Lawyer of the Year"

Dennis A. Mr. Estis is a Charter Fellow of the Litigation Counsel of America and is listed in both *The International Who's Who of Construction Lawyers* and *The International Who's Who of Business Lawyers*. He received the David Pavlovsky "Service to the Bar" Award from the Middlesex County Bar Association where he is the past president. Mr. Estis is the past chair of the Construction Litigation Committee of the Section of Litigation, and a member of the Forum on the Construction Industry of the American Bar Association.

Mr. Estis is co-author of **New Jersey Condominium and Community Association Law**, published by Gann Law Books and of the New Jersey Chapter of CPI Lien Law Online, Construction Publications, Inc. He is the author of "Defending the Developer," Chapter 8 of **Condominium and Homeowner Litigation**, published by John Wiley & Sons.
