Clients retain members of the group to develop and implement appellate strategies before, during, and after trial, and to advise clients on the most effective way to reach favorable results in cases that other law firms have handled. Members of the group are effective in their practice because they are familiar with and experienced in all phases of appeals. Our attorneys routinely:

- Work with our trial attorneys in preparing motions in limine and second chairing trials in high exposure cases in which the record must be preserved;
