Jennifer's environmental compliance counseling practice includes solid and hazardous waste identification, management, and disposal issues under state laws and the Resource Conservation and Recovery Act (RCRA); spill reporting and site remediation obligations under federal and state laws, including RCRA, the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA or Superfund), and state voluntary cleanup and Brownfields programs; and permitting issues under the Clean Water Act and the Clean Air Act.

In her transactional practice, Jennifer conducts environmental due diligence, assesses and allocates environmental liabilities, and identifies and assists companies with obtaining federal, state, and local regulatory approvals necessary for consummation of transactions, including environmental permit transfers.
