Representative Matters

- Represented several trade associations in an *amicus* brief before the Ninth Circuit arguing that the plaintiff lacked standing based on an alleged invasion of privacy from the use of the defendant's session-replay technology on an e-commerce website, helping secure a unanimous decision affirming the dismissal of the lawsuit on this basis.
- Represented a coalition of firearms-industry members in a Supreme Court *amicus* brief opposing a lawsuit brought by Mexico against several gun manufacturers seeking to hold them liable for gun violence in the country, resulting in a unanimous decision that the Protection of Lawful Commerce in Arms Act barred the foreign government's suit.
- Represented a bipartisan, bicameral coalition of Members of Congress in a D.C. Circuit *amicus* brief supporting the Protecting Americans from Foreign Adversary Controlled Applications Act, resulting in a decision upholding the law under the First Amendment and other constitutional provisions.
