In addition, Ms. Ruff served as a member of federal advisory committees to the U.S. Coordinator for International Communications and Information Policy at the Department of State, and to the U.S. Trade Representative and the U.S. Department of Commerce. She was a member of the boards of the U.S. Telecommunications Training Institute and the European-American Business Council, and co-chair of the Digital Trade group of the U.S Council for International Business. She also participated in the the Policy and Spectrum Groups of the GSM Association.

Prior to joining Verizon, Ms. Ruff worked at the International Bureau of the Federal Communications Commission (FCC), where she was Associate Chief and Chief of Staff for the Bureau. Previously, she practiced with the communications and Latin America groups of an international law firm and served on the staff of a United States Senate Committee.

Additionally, Ms. Ruff has fostered "Women in Technology" programs involving Science, Technology, Engineering, and Math (STEM) initiatives, and oversaw the organization of a 2011 conference in Uganda exploring ways to obtain and utilize Internet interconnectivity for higher education purposes.

Ms. Ruff received her J.D. from the Georgetown University Law Center, *magna cum laude* and Order of the Coif. She received her B.A., *cum laude*, and her M.A. from Harvard University.
