Some of those roles included General Counsel to the President's Intelligence Advisory Board in the Executive Office of the President; FBI Acting Privacy Officer; Acting Deputy General Counsel for the FBI's General Law Branch; Brown has also managed four law units within the Bureau including cyber, terrorist screening, counterterrorism, and classified litigation, where she supervised large teams and acted as special counsel to four FBI General Counsels.

Earlier in her career, she served as senior counsel to the Central Intelligence Agency after the terrorist attacks of 9/11 and she helped draft the Intelligence Reform and Terrorism Prevention Act. She subsequently became the first FBI attorney detailed to help stand up the Office of the Director of National Intelligence. She also served as the Senior Counterterrorism Legal Advisor at the National Counterterrorism Center focusing on cyber, data management, information security, risk management, and information sharing. Before entering public service, Brown was in private practice specializing in international law and aviation mass disaster litigation.

Brown earned her J.D. from the University of Florida, where she served on the *Journal of Law and Public Policy* and the *International Law Journal*. She received her M.A. from the Johns Hopkins University and her B.A. from The University of Florida.
